Chairman's Report by Phyllis Norris



Being the voice of business in the heat of the Colorado General Assembly session is no easy task! Just look at the numbers...120 days, over 500 bills to track...100 lawmakers to communicate with...you get the

picture. And this year the pressure is even greater with both Democrats and Republicans laying out their plans for spurring job growth.

That is why the Grand Junction Area Chamber is the only Chamber on the Western Slope that devotes the resources to having a full time Governmental Affairs Manager on staff. With only six people total working for the Chamber you can easily see how much importance the Chamber leadership attaches to being active on behalf of businesses.

Even this early in the session we have taken positions on several bills aimed at reducing regulatory burdens and encouraging business growth. But it is still early in the process and there are some large issues to be addressed in coming weeks including what will become of Pinnacol, our insurer of last resort for workers compensation insurance and Enterprise Zones which have been a valuable economic development tool here in Mesa County.

I urge you to consider getting involved and engaged with us in our efforts. Any Chamber member is welcome to attend our legislative video conferences held twice monthly at Colorado Mesa University. This is your chance for face to face contact with our local delegation where you can learn about legislation and ask questions/ provide input. In February these events will be held at 7:00 AM on February 7th and 21st.

You may also want to consider joining us for the 19th annual Grand Junction Days at the Capitol on March 1st and 2nd. We travel together to Denver, visit with Western Slope lawmakers, key members of the Governor's Cabinet and host a usually well attended dinner with lawmakers from all over the state. This is our major opportunity to be visible as a Chamber and emphasize what our members need from state government in order to grow their businesses. Perhaps the key thing to remember though is that even if you can't be involved you can be reassured that the Chamber has your back and is watching out for your interests with state, federal and local government.

The Chamber's Governmental Affairs activities are off and running. Our videoconference schedule with lawmakers is set and available online at

www.gjchamber.org, and our trip to the State Capitol on March 1st and 2nd will feature meetings with key administrators and lawmakers (see page 5 for details).

At the first meeting of the session the Chamber went on record and began lobbying several business related bills including;

SUPPORT FOR:

HB 1021 sponsored by Representative Bradford which seeks to allow county health departments to regulate and certify home based businesses that produce baked goods such as cupcakes.

HB 1002 that requires the rules in effect on the date of an application for a new or renewed permit govern the application for that permit. In other words, the rules do not change once a business has submitted an application to any state agency for that business, insuring certainty in the process.

HB 1033 waives audit penalties for late reporting of Workers Compensation injuries. Companies already pay a penalty for late reporting. This bill insures that they won't be fined again upon having gone through an audit for the same offense.

Opposition to:

SB 1 which sets up a contracting preference for employing Coloradans. While it appears to be a good thing such a preference creates an unfair playing field and could cost employers and taxpayers more.

SB 3 which prohibits the use of credit checks for employment

information by an employer unless the employee will have access to money. The federal government already has guidelines in using credit in employment decisions.

SB 4 grants a 1% bidding preference to in state procurement contracts for materials manufactured in the United States. Trying to track where all materials come from in a global economy is extremely difficult for most manufacturers and this would unfairly affect smaller manufacturing companies with limited resources.

Chamber Trade Mission To Greece Leaves October 25th

Travel with the Chamber next fall to Athens, the cradle of Western Civilization, and cruise the Greek Isles for seven days with a stopover in Istanbul. The blue waters of the Mediterranean combined with bleached ruins where Socrates and other great Greek intellectuals trod. A complete itinerary of the trip can be found on the Chamber website, www.gjchamber.org. This is another joint trade mission with our neighbors from the Glenwood Springs Chamber so there will be opportunities for networking with our neighbors as well.



Energizing The Economy

(A new feature of our monthly newsletter is a focus on some particular industry or area of focus for the Chamber and how we promote or work with that area. This month we focus on the energy sector.)

Energy is a vital part of the Grand Junction area economy and by energy we mean all sources of energy including traditional, renewable and nontraditional. With the ongoing and increasing need for energy to power everything from cell phones to cars to homes it is important that all potential sources be explored and if economically and environmentally viable to be developed. The Chamber has garnered a lot of attention for our ongoing energy briefing series and rig tours aimed at educating those not in the energy field about recent developments and practices.

Energy briefings are typically held twice a month, 7:30 AM in the Chamber lower level conference room and anyone is welcome to attend. The tentative spring schedule is:
